Take a walk in these shoes

Tim and Nadine have three children. Billy (12yo) and Tiffany (10yo) both are highly autistic and their behaviour includes regularly assaulting both their parents and each other, and significant self-harming by Tiffany. Overwhelmed by the pressures, Tim and Nadine recently separated and came close to relinquishing the children to Government care, due to the physical and mental exhaustion experienced. Although the couple have now reconciled, neither parent is able to work due to the demands of caring. The family's lack of income is worsened by constantly needing to repair damage to their rental property caused by the children. The third child, Mary (7yo), rarely gets enough time or attention from her parents and has no other social interaction with other children except school hours, where she struggles to "fit in". School holidays are particularly difficult for the whole family and the family has not had a social outing for more than 3 years.

This is a story we hear over and over. Families tested to their limits on a daily basis. It's heartbreaking but The Board Meeting Charity wants to do something about it.

Who are The Board Meeting?



HELPING LOCAL KIDS IN NEED

TBM is a dedicated group of volunteers who have been raising much-needed funds for severely physically or mentally disabled Sunshine Coast children and their families for over 12 years. No-one in TBM is paid. All work is performed by volunteers and any admin costs are covered by our generous committee members. Every cent raised goes to the families. We are a registered charity and all donations are fully tax deductible.

The families we help have usually fallen through the cracks of Government support, are doing it extremely tough financially and have children with needs those of us with healthy kids could hardly fathom. Since 2005 The Board Meeting has raised more than \$850,000 for these local families, primarily providing specialized equipment such as customized wheelchairs, walking frames, bed hoists and more.

But there is another piece to the puzzle – the family members who care for these severely disadvantaged kids.

With the demands on the charity continuing to grow, particularly in the areas of respite care and family support, we decided that it was necessary to create an additional arm to The Board Meeting that welcomed new benefactors and allowed us to jointly offer funded care to struggling Local families with disabled kids and provide benefactors with regular updates on the progress of those we are helping.



Introducing the Guardian Program

These families need your help! The Board Meeting assists many families who have problems that aren't simply solved by a one-off payment or piece of equipment. Many of these families have disabled children with on-going requirements and have no options but to turn to the community for help, or go without. This isn't a load anybody should have to bear on their own.

By becoming a Guardian, you are committing to changing the lives of the people who need it most. The funds donated allow us to provide the support these people really need. You really can make a difference!

What is a Guardian?

A Guardian is an individual, family, group or business who is prepared to commit to donating \$250/month by Direct Debit through an initial 1-year renewable sponsorship.

The rewards are simple but the benefits are immense. Firstly, and most importantly, you will know you are helping those most in need in the Sunshine Coast Community. Our aim is to attract 50 Guardians, thereby raising up to \$150,000. So when the going gets tough for these families, we can approve funding to address their needs as fast as possible.

Secondly, we will be hosting a gala event in February each year at the Mooloolaba Surf Club. Maybe a gala ball. Maybe a renowned musical artist. But it will be special - we promise you that. Guardians receive 2 tickets to the gala event and you can invite as many extra paid guests as you like. Food, drinks, entertainment and a hell of a good time is all included.
